The need for increased ventilation while maintaining a comfortable temperature should be balanced.</li> </ul> <p>On dedicated transport:</p> <ul style="list-style-type: none"> <li>It is no longer recommended maximising distance and minimising mixing, but unnecessary risks such as overcrowding should be minimised.</li> <li>Children, young people and adults should follow United Kingdom Health Security Agency (UKHSA) advice on when to self-isolate and what to do.</li> <li>They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li> <li>If a child or young person has one of the main COVID-19 symptoms while at school, they will be sent home.</li> <li>They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li> <li>In exceptional circumstances, if parents or carers cannot arrange to have their child collected, and it is age-appropriate and safe to do so, the child should walk, cycle or scoot home. Personal Protective Equipment Face coverings	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• <b>From 27 January 2022</b>, we no longer recommend that face coverings should be worn by any pupils, students, staff or adult visitors when moving around premises, such as in corridors and communal areas. Everyone should follow wider advice on face coverings outside of education settings, including on transport to and from education settings.</li> <li>• Face coverings in communal areas may temporarily, and exceptionally, be advised by DsPH: for an individual setting, as part of their responsibilities in outbreak management for settings across areas where DfE and public health experts judge the measure to be proportionate, based on the evidence public health experts share with the DFE and specific local public health concerns.</li> <li>• For example, where the area has been designated as an enhanced response area, and where transmission patterns may put exceptional local pressure on the healthcare system.</li> <li>• Children of primary school age and early years children should not be advised to wear face coverings.</li> <li>• Any guidance should allow for circumstances where people are not able to wear face coverings.</li> <li>• In all cases any educational and wellbeing drawbacks in the recommended use of face coverings should be balanced with the benefits in managing transmission. Ill health	Staff Pupils Others	Coronavirus symptoms	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays the main symptoms of Covid 19, such as having a continuous cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> <li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li> <li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li> <li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li> <li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li> <li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their</li> </ul>	MED		✓

Following the latest public health advice, we know that Omicron presents low risk to most children, young people and fully vaccinated adults.</li> <li>Most people will only experience mild or asymptomatic illness which combined with vaccination allows education testing to be in line with the wider society and bring greater normality to the school day.</li> </ul>	LOW		✓

Living in same household with a pupil/sibling with a positive case	Siblings Pupils Others	Spread of infection	<p><b>From 16 August 2021</b>, you will not be required to self-isolate if you live in the same household as someone with COVID-19 and any of the following apply:</p> <ul style="list-style-type: none"> <li>• You are fully vaccinated</li> <li>• <b>You are below the age of 18 years 6 months</b></li> <li>• You have taken part in or are currently part of an approved covid-19 vaccine trial</li> <li>• You are not able to get vaccinated for medical reasons</li> </ul> <p>As long as the pupil/sibling is not displaying any COVID-19 symptoms, then the above guidance applies.</p> <p>Pupils aged 5 years and over and live in the same household as someone with COVID-19, and are not legally required to self-isolate, are strongly advised to:</p> <ul style="list-style-type: none"> <li>• Take an LFD test every day for 7 days, or until 10 days after the household member who has COVID-19 started their self-isolation period if this is earlier</li> </ul>	MED		✓

			<p>The thresholds, detailed below, can be used by settings as an indication for when to seek United Kingdom Health Security Agency (UKHSA) or Local Public Health advice if they are concerned.</p> <p>For most education and childcare settings, whichever of these thresholds is reached first:</p> <ul style="list-style-type: none"> <li>➤ 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or</li> <li>➤ 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period</li> </ul> <ul style="list-style-type: none"> <li>• For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time:</li> <li>• All settings should seek United Kingdom Health Security Agency (UKHSA) or Local Public Health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern. Settings may be offered Local Public Health support in managing risk assessments and communicating with staff and parents.</li> <li>• Settings may wish to seek additional United Kingdom Health Security Agency (UKHSA) or Local Public Health advice if they are concerned about transmission in the setting.</li> </ul>

CEV children	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>The UK Clinical Review Panel has recommended that no children and young people under the age of 18 should be considered CEV and under-18s should be removed from the shielded patient list.</li> <li>Children and young people previously considered CEV should attend school and should follow the same COVID 19 guidance as the rest of the population. They may wish to take extra precautions, however.</li> <li>If a child or young person has been advised to reduce their social contact by their specialist, due to the nature of their medical condition or treatment, rather than because of the pandemic, they should continue to follow the advice of the specialist.</li> </ul>	MED		✓
